By entering the competition, you agree to adhere to our terms and conditions as outlined below.

1. Updating your details as held by Sydney FC using the link in an email sent to the entrant on Wednesday 23rd October 2019 constitutes one entry into the draw.
2. The competition opens at 7pm on Wednesday 23rd October 2019 and closes at 9pm on Friday 25th October 2019.
3. The officers, management and employees (or immediate family of an officer, manager or employee) of the Promoter, the agencies associated with this Competition and their related bodies corporate are not eligible to enter.
4. It is the entrants' responsibility to inform the Promoter [Sydney FC] if their residential address, email address or phone number changes during the Competition Period.
